# Seniors Festival Day Sunday 1 October




Don't forget to come and meet face to face with MHOA committee members who will be in attendance between 11am and 4pm.

# **Update**

We have been advised that the two MHOA members have had successful outcomes before the hearing at VCAT regarding a rebate for not being able to use facilities during Covid. As they signed a confidentiality clause, we are unable to release details, but they were both extremely happy with the outcome.

# **Energy Bill Relief Program for Embedded Network residents**

Whilst most concession card holder households will receive their Energy Bill Relief payment of \$250 through their energy retailer, households in embedded networks will need to apply for the program through the Victorian Energy Compare website.

# **Home Insurance Legislation**

Many Site Agreements have a clause inserted whereby it is <u>mandatory</u> for the home owner to have an insurance policy for their home. Under the Residential Tenancies Amendment Act 2018, part 6 – Amendments relating to site agreements and Part 4A dwellings a new section 206FA has been inserted which reads in part:

#### 206FA Prohibited terms – general

- (1) A site agreement must not include any of the following terms -
  - (a) a term that requires the site tenant to take out any form of insurance;

However, whilst not mandatory, we highly recommend insurance on your home.

However, not all insurance companies will insure "manufactured homes."

We know that MHIA, RACV, ALLIANZ, YOUi, Bendigo Bank will insure manufactured homes, but some are 2-3 times higher than others. YOU NEED TO DO YOUR RESEARCH.

If you are aware of others, please let us know.

# September Roundup
